Elfring Fonts Inc. End User License Agreement

This End User License Agreement ("Agreement") is a legal Agreement between you (either on behalf of yourself as an individual or on behalf of an entity as its authorized representative) and Elfring Fonts, Inc. Please read this Agreement before purchasing, downloading, installing or using the Font Software. This Agreement supersedes all previous versions. This Agreement is governed by the laws of the state of Illinois.

By checking the "I accept the agreement" box and/or installing, copying, or otherwise using Elfring Fonts, Inc Software you agree to be bound by the terms of this Agreement. If you do not agree to the terms of this Agreement, click on the "I do not accept the agreement" button and then click "Cancel". Do not install, copy, or use the Software.

- **1. SOFTWARE:** As used in this Agreement, the term "Software" refers to the Elfring Fonts Inc. software which you have selected to install. The term "Software" also shall include any upgrades, modified versions or updates of the Software made available to you by Elfring Fonts Inc. The Software is deemed accepted by you upon installation of the Software. The term "Software" also includes any third-party software made available to you by Elfring Fonts Inc.
- **2. GRANT OF LICENSE:** Subject to the terms of this Agreement, Elfring Fonts Inc hereby grants you a perpetual, non-exclusive, terminable, non-transferable right to: (i) to use one copy of the Software solely for one person's use on one computer per purchased copy of the software. (ii) You agree that you will not sublicense, assign, transfer, distribute, pledge, lease, rent or share your rights under this License except with prior written permission from Elfring Fonts Inc. (iii) You agree that you will not modify, adapt or translate, or disassemble, decompile, reverse engineer or otherwise attempt to discover the source code of the Software.

This user license agreement **restricts** the use of these fonts from Elfring Fonts Inc for broadcast use in a video, internet streaming, program, movie, commercial or in multi-media titling for broadcast online, on television, mobile devices or movie theaters, or any new technologies that may be developed in the future, without the purchase of an additional license. These fonts may only be used for printed media applications with this additional license upgrade.

- **3.
